Catalan Journal of Linguistics publishes research papers in theoretical linguistics developing theories on the structure of particular languages within the perspective of a general theory of the human language. Volumes will often be monographic, edited by a specialist in the topic.

Catalan Journal of Linguistics is surveyed (for indexing and abstracting) by Current Contents Linguistik (CCL), Bibliographie Linguistique/Linguistic Bibliography, Linguistic Abstracts (LA) and Linguistics and Language Behavior Abstracts (LLBA).

Catalan Journal of Linguistics style sheet

- **Text processor.** Both a hard copy and an electronic version of the paper are required. The diskette has to be submitted in Word for Macintosh or PC.
- **Format.** Font 12 point Times, interline at 1.5, use default margins (2,5 cm or 1 inch). Do not insert or force (with blank lines) any page break (even if that implies that representations or sets of examples remain split).
- **Heading.** Left-justification. Title, with title capitalisation, in boldface. Name of the author, research center (written as a complete mail address) and e-mail address. Acknowledgements, as a footnote, called by a flying asterisk at the end of the title.
- **Abstracts.** A 150 word abstract is required. A Catalan version of the abstract should be included at the end of the article. Authors are also asked to provide the key words of the article.
- **Headings of sections and paragraphs.** Headings of main sections: in boldface. Headings of first order paragraphs: in italics. Headings of second order paragraphs or others: in italics with text beginning at the same line.
- **Examples.** Example numbers should go between brackets, left aligned (Arabic digits for examples in the text; lower case Romans for examples in footnotes). Example texts should start at the first tab. If there is more than one example within a number, lower case Roman should be used followed by a stop and a tab. Examples must be referred to as (1), (5a,b), (6b-d), (ii), (iii c-e), (iv a,b), etc.
- **Glosses and translations in examples.** Examples from languages other than English should be accompanied by a gloss and, if necessary, by a translation into English. Align glosses with examples word by word. Translations should be in simple quotation marks. Sentences should end with a final stop (before the ending quotation mark).
- **Text.** The beginning of a paragraph should be left indented, except for the first paragraph of a section. References in the text should follow this format: Chomsky (1981), Kayne (1981, 1982), Belletti and Rizzi (forthcoming), Jackendoff (p.c.). If they indicate the page number or an example: Rizzi (1990: 20), Rizzi (1990: ex. (24)).
- **General remarks.** No underline, no boldface except for titles, simple quotation marks only for translations. Phonetic characters should be created with SIL-Doulos IPA. Words, phrases or sentences in a language other than English appearing in the body of the text should be followed by a translation in parentheses and simple quotation marks.
- **References.** References should be according to the following pattern, with full names of authors included.
 - a) **Book:**
Borer, Hagit (1983). *Parametric Syntax*. Dordrecht: Foris.
 - b) **Journal article:**
Harris, James (1991). «The Exponence of Gender in Spanish». *Linguistic Inquiry* 22: 27-62.
 - c) **Book article:**
Jaeggli, Osvaldo; Safir, Ken (1989). «The Null Subject Parameter and Parametric Theory». In: Jaeggli, Osvaldo; Safir, Ken (eds.). *The Null Subject Parameter*. Dordrecht: Kluwer, pp. 23-91.
 - d) **Dissertation, manuscript, or work in preparation:**
Pesetsky, David (1982). *Paths and Categories*. MIT, doctoral dissertation.
Chomsky, Noam (1994). «Categories and Transformations». MIT, unpublished manuscript.
